## **General comments:**

Kingaroy Golf Club operates under a Management Committee, rather than a Board.

The Women in Golf Action Group is currently comprised of the Club President, Club Secretary, and 6 women members who volunteered. Club membership has been informed of the progress of the working party through email and newsletter, and a women's group face-to-face update.

Female membership at Kingaroy Golf Club has grown from 28 in 2017 to 66 in 2025.

Kingaroy Golf Club website is currently being redeveloped. This will allow for on-line bookings for both competition and social golf, and far better promotion of documents such as GA's leadership statement and the Women in Golf Charter. It will also allow for easy access to official club documents and policies.
